



Recruitment to the Posts of Drivers in Telecommunication Regulatory Commission of Sri Lanka

Applications are invited from eligible applicants to fill the vacancies in the posts of Drivers in Sri Lanka Telecommunication Regulatory Commission.

(1) Qualifications for recruitment :

Educational / Professional Qualifications / Experience

Educational Qualifications :

- Shall have passed six subjects in G.C.E. Ordinary Level in not more than two sittings with at least two credits including Sinhala/Tamil language.

Professional Qualifications :

- Having a motor vehicle driving license issued by the Commissioner General of Motor Transport for driving private/taxi vehicles and station wagons of less than 24 tonne capacity.
(Must hold at least C and C1 vehicle class license or B class license as per new driving license 3 years before the date of recruitment)
- Proper knowledge on the highway code.

Experience :

- Shall have 03 years of Service Experience as a Driver. (Experience should be verified by certificates)

(2) Age- Should be between 18-45

(3) Method of Recruitment :

Recruitment is done through a structured interview and a practical test, and appointments are made on the basis of marks obtained in both the structured interview and the practical test.

(4) Salary : TRC 10.1 - Rs. 40,800 (10x480) - (10x680) - (10x1020) - (10x1360) - Rs. 76,200

(5) Closing Date of Applications - 10.08.2023

(6) General Conditions :

- The appointment is permanent and subject to a probation period of 03 years.
- Applications of the applicants who have not satisfied relevant qualifications as at the closing date of applications and who have not submitted with relevant certified certificates along with the application shall not be considered.
- The Sri Lanka Telecommunications Regulatory Commission reserves the right to decide on the number of posts to be recruited or the postponement/cancellation of recruitment.
- Since Sri Lanka Telecommunication Regulatory Commission is a regulatory body, any person recruited to its service shall not directly or indirectly support/encourage or advocate the recruitment or appointment of his/her spouse or family member to a position in an institution under the regulatory control of the Commission.

(7) Method of Applications :

Applicants who have satisfied basic qualifications should send their applications to the following address via registered post along with certified photocopies of educational/ professional qualifications before the closing date. If the applicant is already in public service, the application should be submitted with the recommendation of the head of the relevant institution stating that there is no hindrance to release the applicant from service if selected for the position.
